

# RUGBY LEAGUE WORLD CUP 2017 PROSPECTIVE LICENSEE APPLICATION

Thank you for your interest in becoming a licensee of the Rugby League World Cup 2017 (RLWC 2017).

Please be advised that the RLWC 2017 is a centrally managed licensing program across the RLWC 2017 Tournament and the 14 teams competing and VBM has the exclusive rights to license for commercial purposes including but not limited to the manufacture, distribution and sales of products bearing the marks of RLWC 2017 intellectual property and all participating nations IP. For the avoidance of doubt, intellectual property refers to but not limited to team names, primary logos, secondary logos, wordmarks, design symbols and uniforms, in addition to any special event programs such as Finals/ Championship marks as well as the name, image and likeness of any RLWC 2017 players (when applied in collective form, as per terms of respective Players Association agreement).

Only officially licensed merchandise may carry the logos and marks of the RLWC 2017 Tournament vigorously protects the ownership of its intellectual property and will, as appropriate, take legal action against any unauthorised use of these symbols or any unauthorised attempt to associate any company, product or service with the RLWC 2017 or any related marks or logos.

You should be aware that all product license agreements issued by RLWC 2017 will require, at a minimum, the following:

- a) A minimum guarantee commitment for the tournament year
- b) Royalty payment on the net sale of each licensed product sold, with sales remitted on a quarterly basis.
- c) Annual advertising and marketing fund commitment
- d) Evidence of public and product liability insurance of a minimum of \$10 million (AUD)

Furthermore, a condition to RLWC 2017 issuing a product license agreement, the applicant must have an established distribution and salesforce in the territories license is being sought to actively promote the sale of the licensed range with evidence of this distribution and salesforce shown throughout this document.

VBM and RLWC 2017 receives numerous product licensing applications and requests with many of the ideas presented to the RLWC 2017 by prospective licensees and otherwise are similar or identical in nature. Please note that by lodging this application form you agree to release and discharge the RLWC 2017 and each of its related bodies corporate and the directors, servants and agents of each of them (**related parties**) severally from any claim, action, demand, suit or proceeding for damages, debt, restitution, equitable compensation, account, injunction, specific performance or any other remedy that you or the entity on behalf of which this application is submitted,



may have against the RLWC 2017 or any of its related parties in respect of any of the ideas or material contained in or connected with this application.

Nothing in this application form shall give rise to any legal or professional relationship between the applicant and the RLWC 2017. Please also note that completion and submission of this application does not grant the applicant any rights or license to use any intellectual property of the RLWC 2017 or its related bodies corporate.

VBM (for and on behalf of RLWC 2017) will review and evaluate prospective licensee submissions and may or may not choose to contact applicants to discuss their application and the products disclosed therein. Please note that RLWC 2017 does not have any obligation to grant you a license by providing you with this application and/or any supporting materials relating to this application.

Please allow a minimum of six (6) weeks from receipt of application for RLWC 2017 review.

#### **Frequently Asked Questions**

#### Q: What are minimum guarantees?

A: A minimum guarantee is the agreed minimum financial payment that must be paid by the licensee to the RLWC 2017.

The RLWC 2017 may require all or part of the minimum guarantee to be paid up front upon signing of a new licensee agreement and/or a bank guarantee for the total value of the minimum guarantee, less any upfront payment.

The minimum guarantee is off-set by royalties paid on wholesale sales and annual payments mutually exclusive for the tournament year

#### Q: How are minimum guarantees amounts determined

A: Minimum Guarantee amounts vary depending on the category and product being licensed, however the base minimum guarantee for RLWC 2017 will commence at \$10,000 (unless otherwise determined, on a case by case basis by RLWC 2017

In determining minimum guarantees, the RLWC 2017considers many factors including but not limited to: wholesale pricing, projected sales / distribution channels information submitted by prospective licensees.

### Q: What is the base royalty rate?

A: The base royalty rate for all RLWC 2017 licensed merchandise will commence at fifteen percent (15%) of wholesale selling price for retail distribution.

Higher royalty rates will apply for use of player imagery & direct to retail rates may also apply.

#### Q: What is the advertising and marketing fund commitment?

A: The advertising and marketing fund is a mandatory annual contribution from licensees (in addition to minimum guarantee payments) which is used by RLWC 2017 in consultation with the license to conduct an integrated advertising, marketing and/or PR plan for the licensing program.

## Q: Will RLWC 2017 sign a confidentiality agreement?

A: No, you should not include any information or material with your license application that you want to keep confidential.

# Q: I do not have an established retail distribution, will it affect my chances of getting a license?

A: Yes, if you cannot provide sales projections based on retail expectations and/or you do not have established distribution channels (either in-house sales force or appointed distribution agent) that will be used to promote the sale of the licensed products in the territory being sought, we recommend waiting to apply until you can do so.

#### Q: How long will the entire application process take?

A: Allow a minimum of six weeks for the review and response to your application.
